TERMINATION OF MEMBERSHIP

- a. A member may resign from membership and upon acceptance of he/she/its resignation by the Association, he/she/it shall cease to be a member.
- b. The annual subscription of member shall become due on 1st April of each year. If the subscription is not paid within 60 days from the 1st April of each year, the member will be deemed to be a defaulter. - c. A member who causes damage or prejudice to the Association or who does not comply with the rules and regulations of the Association may be expelled from membership of the Association by a resolution of the board Members of the Association.
