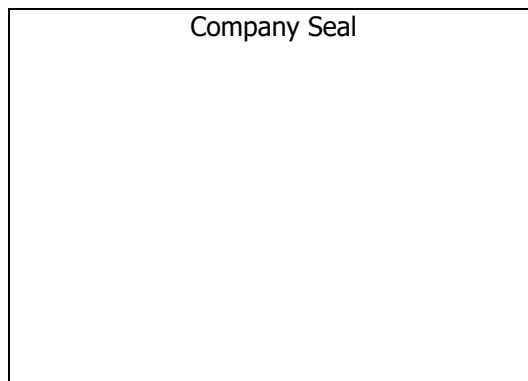

TERMINATION OF MEMBERSHIP
